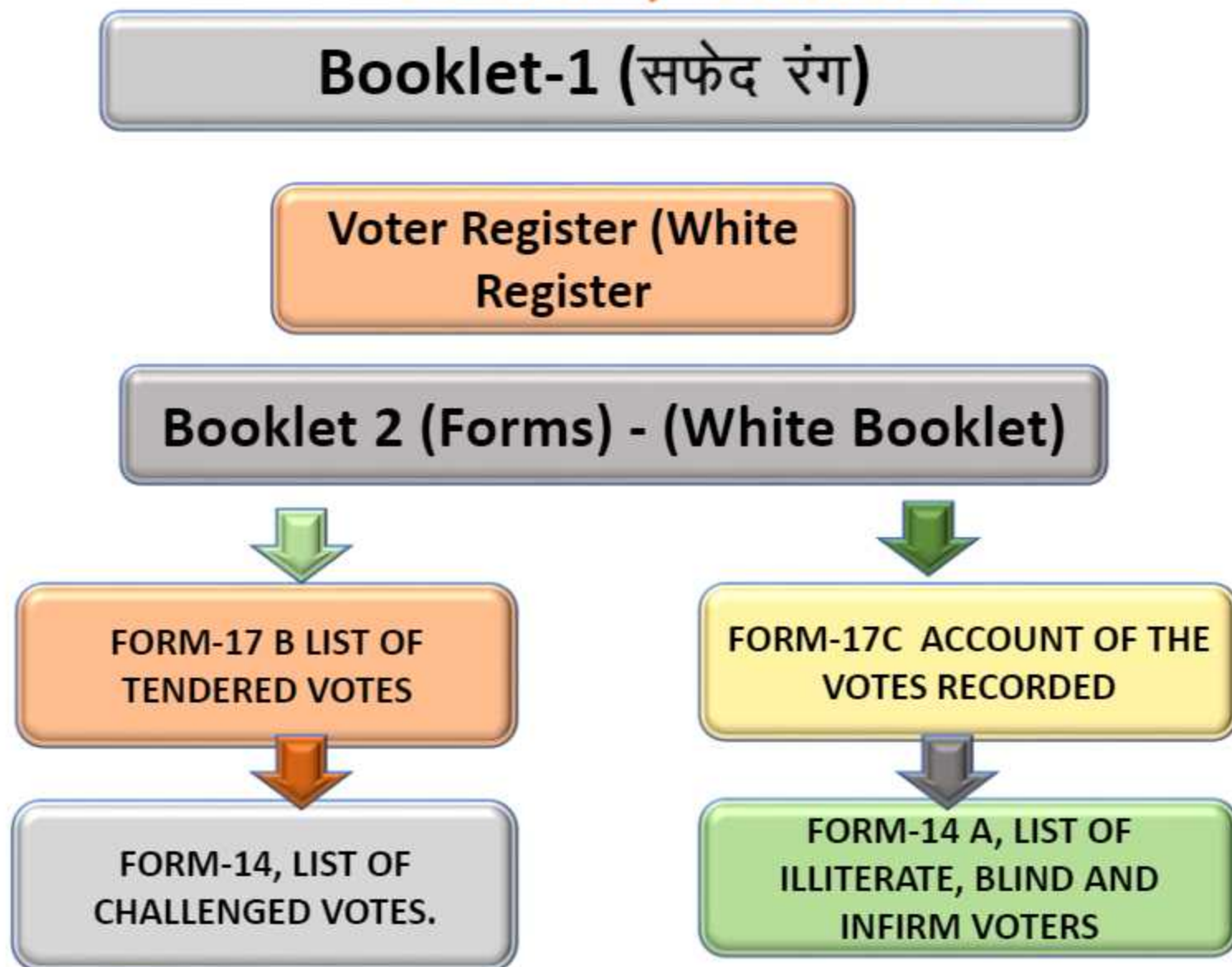

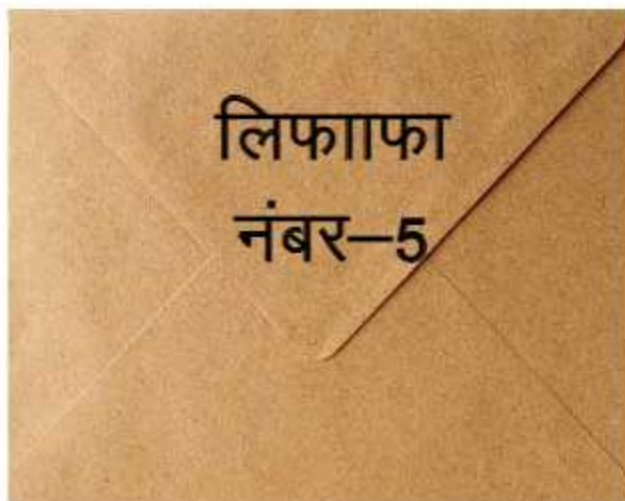

- 1- Unsealed envelope containing the Presiding Officer's Diary**
- 2- Sealed envelope containing the register of voters (17A)**
- 3- Unsealed envelope containing Visit Sheet**
- 4- Unsealed envelope containing the list of blind and infirm electors in Form 14-A and the declarations of the companions.**

All the above election papers should be kept in unsealed white coloured master envelope (Envelope No: 2/1) and Polling Station wise scrutiny cover required for scrutiny should be stored separately in a strong room other than Polled EVM strongroom having polled EVMs and VVPATs.
